This will confirm and reserve your event date. The non refundable booking fee will be applied to the agreed upon fee as stated above, unless the first named cancels the contract thereby forfeiting the booking fee. The balance of the contract will be due In Full **FIVE** Days Before the engagement time and date. If the balance due is not paid five days before the event date the entertainer will not arrive and you will forfeit the deposit. The following charges will only apply to those situations that are directly related to the event and location. Please check with the event location to verify if these situations apply to your event. A **\$75 fee** will apply to this contract for any location that does not offer a paved access, elevator, or reasonable ramp to move equipment for loading. A **\$50 fee** for parking will apply to locations that charge for parking. Parking for the entertainer will need to be arranged by the first named, **a fee will not apply if** the first named has paid for parking. Electrical Power for the engagement time must be provided by the first named, or event location, and include any power cables over 100 feet. Generators are OK for power. If the event is outdoors, the first named and/or the event location must provide shade from Sun and/or a heater from the cold, if needed for the entertainer and the equipment. If shade and/or a heater is not provided by first named or event location, a **\$100 fee** for equipment rental will apply to this contract.
